Dawlada Alberta waxay kala shaqaynaysaa Golaha limaamyada Alberta iyo Masaajidka Al Rashid sidii loo qiiimayn lahaa fursadaha maal gashiga islaamiga ah, ama xalaasha ah.

Sanadkii 2022, dawlada Alberta ayaa soo saartay naqshada sharciga si loo siiyo ganacsiyada shardi dhaaf kooban oo ku aadan shuruudaha sharciga iyo xeerarka qaarkood, taasoo u sahlaysa inay cilmibaaris iyo suuq gayn u sameeyaan badeecoooyinkooda iyo adeegyada ku cusub suuqa.

Hadda, Muslimiin badan ayaan awoodin inay helaan maalgelinta daymaha guryaha ee caadiga ah oo ay baxshaan xarumaha dhaqaalaha ee sharciga ah, maadaama bixinta ama qaadista lacagta dulsaarka ah ay xaaraan ka tahay sharciga Islaamka. Maalgelinta xalaasha ah ayaa daynta guryaha siinaysa guryo iibsadeyaasha u qalma ayadoo la adeegsanaayo qarashaad iyo lacago badel u ah qarashaadka caadiga ah ee daynta guryaha.

Alberta ayaa dejisay farsamooyin si ay u taageerto abuurista maalgelinta xalaasha ah. Shardi dhaafka sharciga ee Alberta ayaa gacan ka gaysan kara abuurista maalgelin xalaal ah oo lagu dhaqan gasho si degdeg ah. Wuxuu sidoo kale abuurayaa fursad lagu xaqijinaayo in isbadellada sharci ee loo baahan yahay ay waafaqsan yihin sharciga Islaamka.

In Alberta ay noqoto meel ay fududahay in qofku ku dhaqmo kuna noolaado diintiisa ayaa qayb muhiim ah u ah dhisida Alberta nabadgallyo iyo sinaan ay ku haystaan dadka ka kala yimid daafaha caalamka kuwaasoo ku riyoonaaaya nolol wanaagsan.”
