<input type="checkbox"/> <b>Immigration, Refugees and Citizenship Canada (IRCC) forms</b>	<p><b>Attach copy</b></p> <ul style="list-style-type: none"> <li>■ <b>Candidate:</b> IMM 0008 Generic, IMM 5669 Schedule A, IMM 0008 Schedules 4 and 4A, IMM 5406. Include the IMM 5476 and IMM 0008DEP if necessary.</li> <li>■ <b>Spouse/Common-law partner and dependants over 18:</b> IMM 5669 Schedule A, IMM 5406. Include the IMM 5476 if necessary.</li> </ul>

<input type="checkbox"/> <b>Education</b>	<p><b>Attach copy</b></p> <ul style="list-style-type: none"> <li>■ Degree, diploma, certificate, licenses and any other supporting documents relevant to performing a complete eligibility assessment.</li> </ul>

<input type="checkbox"/> <b>Reference letters</b>	<p><b>Attach copy</b></p> <ul style="list-style-type: none"> <li>■ Work-related reference letters from previous employers related to the job</li> <li>■ Must be signed by the employer, dated and on company letterhead and include: <ul style="list-style-type: none"> <li>• Job title</li> <li>• Main duties and education required for the job</li> <li>• Period worked</li> </ul> </li> <li>■ Reference letters may include financial documentation of your existing farm enterprise.</li> </ul>
<input type="checkbox"/> <b>Personal net worth statement</b>	<p><b>Attach certified true copy</b></p> <ul style="list-style-type: none"> <li>■ An accountant prepared statement showing you have a minimum net worth of \$500,000 in unencumbered Canadian funds.</li> </ul>
<input type="checkbox"/> <b>Proposed business plan</b>	<p><b>Attach copy</b></p> <ul style="list-style-type: none"> <li>■ Provide a copy of the proposed business plan.</li> </ul>
<input type="checkbox"/> <b>Canadian financial institution endorsement</b>	<p><b>Attach copy</b></p> <ul style="list-style-type: none"> <li>■ Proof that a Canadian financial institution is willing to finance your proposed Farming business. <ul style="list-style-type: none"> <li>• Must be on institution letterhead.</li> </ul> </li> <li>■ For business plans that do not require funding from a Canadian lender, you must supply a letter from a financial institution indicating they have reviewed your business plans and financials.</li> </ul>
