

## Alberta Advantage Immigration Program – National Occupational Classification (NOC) 2016 criteria for Alberta Opportunity Stream applications submitted on or before November 15, 2022

On November 16, 2022, Immigration, Refugees and Citizenship Canada (IRCC) and the Alberta Advantage Immigration Program (AAIP) adopted the 2021 version of the National Occupational Classification (NOC).

Alberta Opportunity Stream applications submitted on or before November 15, 2022 will be assessed against the selection criteria posted on the AAIP website as of November 15, 2022. The NOC 2016 version of the ineligible occupation list, language requirements, and job offer wage requirements for religious workers is provided below. All other Alberta Opportunity Stream requirements did not change with the move to NOC 2021 and are set out on the [Alberta Opportunity Stream Eligibility page](#).

### Occupation requirements

#### ***Eligible occupations***

At the time your application is submitted, and at the time the AAIP assesses your application, you must work in an eligible occupation in Alberta. Occupation requirements also apply to your work experience and job offer.

You must review the work experience criteria and eligible job offer criteria sections below for details.

The occupation you are working in at the time your application is submitted is your 'current occupation'.

Most occupations under National Occupational Classification (NOC) skill levels 0, A, B, C and D are eligible under the AAIP.

#### ***Ineligible occupations***

Individuals working in the following occupations at the time of submission and assessment are not eligible to apply for or be nominated under the Alberta Opportunity Stream.

\*This National Occupation Classification (NOC) code consists of both eligible occupations and ineligible occupations. The 'Occupation' column specifies which occupations are ineligible for each NOC Code listed.

## Language requirements

You must demonstrate you meet the following language test score in English or French at the time that you submit your application. You must meet the scores based on a single test result.

**Table 2.** Language requirements

<b>National Occupational Classification (NOC) Skill Level</b>	<b>Canadian Language Benchmark (CLB) test score required</b>	<b>Niveaux de compétence linguistique canadiens (NCLC) test score required</b>
If you are working in a NOC 0, A or B occupation	Minimum of 5 for each English language skill	Minimum of 5 for each French language skill
If you are working in a NOC C or D occupation	Minimum of 4 for each English language skill	Minimum of 4 for each French language skill

If you apply to the AAIP under NOC code 3413 (nurse aides, orderlies and patient service associates), the AAIP requires a minimum language test score of CLB of 7 for each English language skill, or NCLC of 7 for each French language skill.

You must provide your official test results with your AAIP application for one of the following language tests:

Official test results must be less than 2 years old at the time your application was submitted. The date used to determine the age of your tests results is the date you took the test, not the date your test results were released. The AAIP will not accept confirmation of registration to take a language test in place of a test result.

### **Job offer requirements – religious worker wage requirements only**

- exceptions for NOC 4154 – Professional occupations in religion and NOC 4217 – Other religious occupations:
  - If your job offer is LMIA exempt, your wages and benefits must meet or exceed minimum wage.
  - Meal and lodging deductions that meet Employment Standards are permitted. Proof of employee authorization of deductions is required.
