## **THE CONSULAR CORPS**

The Alberta government values the contribution made to the province by the Consular Corps members in Edmonton, Calgary, Vancouver, Toronto and Montreal. At a time of growing interdependence the Province of Alberta recognizes more than ever the importance of international trade and investment.

The Consular Corps in Alberta comprises the consular officers resident in the Province of Alberta, representing fifty seven countries from all areas of the world; currently nine of these countries have no representation in Alberta. In addition, certain consular officers who are located outside of Alberta have jurisdiction in the province.

Consular officers are of two categories, career consular officers and honorary consular officers.

### **The career consular officers in Alberta are:**

**Japan - Consul General – Mr. Yasuo Minemura – Appointed April 24, 2008**

**United States of America – Consul General—Ms. Laura Lochman-Appointed July 13, 2009**

**The People’s Republic of China – Consul General – Ms. Liu Yongfeng-Appointed August 30, 2010**

**The Republic of France-Consul-Mr. Jean-Charles Bou—Appointed September 9, 2010**

**United Mexican States – Consul – Vacant.**

Career consuls are posted from their home country. A local resident may be appointed as an honorary consular officer.

Heads of consular posts are divided into four classes, namely:

**CONSULS GENERAL  
CONSULS  
VICE-CONSULS  
AND  
CONSULAR AGENTS**

The premises of a consular officer are referred to as a consulate general, a consulate, vice-consulate or a consular agency as the case may be.

Seniority in the Consular Corps is determined by the original date on which a consular officer assumes his obligations at a post.

The main functions performed by consular officers are:

- to represent their country and promote their country's trade and tourism within the consular district;
- to assist and protect nations of the country they represent;
- to explain their country's policies and achievements; and
- to administer oaths, legalize foreign documents and to issue passports, visas and certificates.
