

Certificate of Independent Bid Determination

Alberta Agriculture and Forestry has prepared this Certificate of Independent Bid Determination for the use when calling for bids, tenders or quotations in respect to the sale or disposition of natural resources or when purchasing goods or services through a competitive process. The purpose of this certificate is to encourage compliance with the [Competition Act, R.S.C. 1985. c.34.](#)

- The Certification of Independent Bid Determination must be completed and submitted with and attached to the Tender package or quotation or otherwise completed and submitted by the successful bidder immediately following the sale by auction.
- Failure of the party to complete and attach the Certificate of Independent Bid Determination to the tender package or quotation or to submit the Certification of Independent Bid Determination upon completion of the party's successful bid at the auction will result in the disqualification of the tender, quotation or bid, as the case may be.

I, _____ in submitting the accompanying bid, quotation or Tender (the "bid") to Alberta Agriculture and Forestry for standing timber described as _____, in response to notice of the call or request for bides (the "call") made by Alberta Agriculture and Forestry, do hereby make the following statements that I certify to be true and complete in every respect.

I HEREBY CERTIFY, on behalf of _____ (the "Bidder"), that:

1. I understand that the accompanying Bid will be disqualified if this Certificate is found not to be true and complete in every respect;
2. I am the Bidder and am authorized by the Bidder to sign this Certificate, and to submit the accompanying Bid, on behalf of the Bidder;
3. For the purposes of the Certificate and the accompanying Bid, I understand that the word "Competitor" shall include any person or organization other than the Bidder, Whether or not affiliated with the Bidder, Who:
 - a. has been requested to submit a bid in response to the call, and
 - b. could potentially submit a bid in response to the call, based on their qualifications, abilities or experiences;
4. The Bidder has arrived at the accompanying Bid independently from and without consultation, communication, agreement or arrangement with any Competitor.
5. In particular, there has been no consultation, communication, agreement or arrangement with and Competitor regarding:
 - a. prices,
 - b. methods, factors or formulas used to calculated prices,
 - c. the intention or decision to submit, or not to submit, the bide or
 - d. the submission of a bid which does not meet the specifications of the Call;
6. In addition, there has been not consultation, communication, agreement or arrangement with any competitor regarding the quality, quantity, specifications or delivery particulars to the products or services to which the call related;
7. The terms of the accompanying Bid have not been, and will not be, knowingly disclosed by the bidder, directly or indirectly, to any competitor, prior to the date and time of the official bid opening, or at the awarding of the contract, whichever comes first, or the time that the bid is made, unless otherwise required by law; and
8. I have read and understand the contents of the Certificate.

I HEREBY ACKNOWLEDGE that the forgoing information may be used and disclosed by Alberta Agriculture and Forestry for the purposes of and investigations or prosecution, both criminal and civil, in respect to any matter for which this Certificate was executed **AND CONSENT** to this Certificate being used and disclosed for such purposes.
