



Application for Exemption from Requirement to Obtain a Reclamation Certificate Due to Presence of an Overlapping Activity¹

This form **must** accompany the application for reclamation certificate from Operator A and be signed by **both** operators. (When the site is completely overlapped no application for reclamation certificate is required.) The area to be certified **and** the area being exempted must be clearly identified on the survey plan submitted.

Please note that while the application form contemplates agreement between the operators of overlapping activities and mutual agreement is ideal, consent is **not** required. The *Conservation and Reclamation Regulation* allows the Alberta Environment and Parks Director/Alberta Energy Regulator to exempt an Operator from getting a reclamation certificate when the activity has been overlapped by another activity that meets the definition of specified land (s. 15.1(1)(b)). Consequently, an overlapped operator may still apply to Alberta Environment and Parks or the Alberta Energy Regulator, as the case may be, for an overlapping exemption where the Operator is unable to obtain consent from the overlapping party.
