The Calgary Police Service is issuing the following public information and warning in regards to the release of an inmate, in the interest of public safety.

Danny Edward DEPEW, is in the Calgary area having served a Five and a half year federal prison sentence for Sexual Assault (x2), Sexual Exploitation (x3). He will now be monitored by the Calgary Police Service High Risk Offender Program on a Section 810.1 Criminal Code Recognizance Order for a period of two (2) years. Danny Edward DEPEW was convicted of the following relevant offences on the following dates:
