The Calgary Police Service is issuing the following public information and warning in regards to the release of an inmate, in the interest of public safety.

Derek Ross CALF-CHILD is in the Calgary area having served a 56 month federal prison sentence for Sexual Assault Causing Bodily Harm (x1). He will now be monitored by the Calgary Police Service High Risk Offender Program on a Section 810.2 Criminal Code Recognizance Order for a period of two (2) years. Derek Ross CALF-CHILD was convicted of the following relevant offences on the following dates:

Members of the public are advised that the intent of the process is to enable members of the public to take suitable precautionary measures and not to embark on any form of vigilante action.
