Public information and warning: Sexual Offender Released

In the interest of public safety, the Edmonton Police Service is issuing the following warning; **Russell SIKYEA is a convicted sexual offender and the Edmonton Police Service has reasonable grounds to believe he will commit another sexual offence against someone while in the community.**

SIKYEA will be residing in the Edmonton area. The Edmonton Police Service is seeking a recognizance order on SIKYEA and he will be monitored by the Behavioural Assessment Unit of the Edmonton Police Service.

SIKYEA has a history of breaking into residences and sexually assaulting adult females. His risk for violence, including sexual violence, increases with the consumption of drugs and alcohol.

SIKYEA has been placed on a series of court ordered conditions including:

- He must abide by a curfew of 10 PM to 6 AM daily.
- He must not leave the City of Edmonton without prior written permission.
- He must not purchase, possess or consume any alcoholic beverages. He shall not consume or possess any drug listed in the schedules of the Controlled Drugs and Substances Act including cannabis, any prescription drugs not prescribed to you, or any other intoxicating substances.
- He shall not be in any licensed premises other than a dining room for the sole purpose of having a meal. He shall not attend at any liquor store.
- He shall not possess any drug paraphernalia such as crack or marijuana pipes, self-made pipes of any kind, e cigarettes, bongs, water pipes, cigarette papers, or syringes.
- He shall not enter into a dating, intimate, sexual relationship with any person, or any friendships with females until her identity has been disclosed to your Supervisor or designate and she has been informed of your previous offending by your Supervisor or designate.

The Edmonton Police Service is issuing this information and warning after careful deliberation of all related issues, including privacy concerns, in the belief that it is clearly in the public interest to inform the members of the community.
