

Request for a Nomination Extension

Personal information you provide to Alberta Immigrant Nominee Program (AINP), Alberta Labour and Immigration for the AINP is collected under the authorization of Section 8 of the Government Organization Act and Section 33(c) of the Freedom of Information Protection of Privacy (FOIP) Act and is managed in accordance with Part 2 of the FOIP Act. Your personal information will be used by the AINP for the purpose of administering the AINP including to evaluate eligibility for the program, maintain program integrity, evaluate program effectiveness and support provision of future services from the Government of Alberta. Your Alberta Immigrant Nominee Program (AINP) Nomination gives you six (6) months to submit your Application for Permanent Residence as a Provincial Nominee to Immigration, Refugees and Citizenship Canada (IRCC). You are expected to submit your complete application to IRCC before your AINP nomination expires. If your nomination expires and you request an extension, the reasons why you need an extension will be reviewed by the AINP. Before submitting a request for a nomination extension, ensure you have read the information and conditions stated in the After you are nominated section for your stream on the AINP website. **There is no guarantee that you will be issued an extension.**

To request a nomination extension from the AINP, complete this form, assemble any supporting documents required and email to the AINP. The AINP's email address can be found on the bottom of page 3 of this form. The AINP will not accept incomplete forms, forms without supporting documents, or forms submitted by mail or fax.

Extension requests will take up to 30 days to process. The AINP will not respond to any status inquiries about nomination extension requests. The AINP will not confirm receipt of documents.
