WHY IS THE TRIBUNAL ASKING THIS? When a landowner applies for recovery of rentals, the Tribunal must decide whether to direct the Minister to pay the full amount claimed, a lesser amount, or to not direct any payment. The Tribunal may choose to direct the Minister to pay a reduced amount if payment of the full rentals would over-compensate the landowner. One of the factors the Tribunal can use to make this decision is the condition of the leased area, how you are using it, how it is affecting the rest of your land, and what losses you are suffering because of it.
