

Sample Wording for section 7 of Schedule 1 Right of Entry Application

A) Well site only (s.12(1)(a) & (b) of the Act)

for the removal of minerals contained in or underlying the surface of that land or for or incidental to any drilling operations, and for the construction of tanks, stations and structures for or in connection with a drilling operation, or the production of minerals, or for or incidental to the operation of those tanks, stations and structures.

B) For a road only going to a well site on the same quarter (s.12(3)(b)(ii) of the Act)

to give the operator access to the operator's drilling operations from a public roadway or other public way, and egress from the operations to the public roadway or other public way.

C) For a road going to a well site on adjacent land (s.12(3)(b)(i) of the Act)

for a road to connect the operator's drilling operations located on adjacent land and to permit the operations to be operated jointly, and for the tanks, stations and structures to be used in the operations.

D) For a well site & road on the same quarter (s. 12(1)(a) & (b) and 12(3)(b)(ii) of the Act)

Note: you may use this same wording for an existing well site and roadway for operations only

for the removal of minerals contained in or underlying the surface of that land or for or incidental to any drilling operations, and for the construction of tanks, stations and structures for or in connection with a drilling operation, or the production of minerals, or for or incidental to the operation of those tanks, stations and structures and to give the operator access to the operator's drilling operations from a public roadway or other public way, and egress from the operations to the public roadway or other public way.

E) For a battery site (s. 12(1)(b) of the Act)

for the construction of tanks, stations and structures for or in connection with a drilling operation, or the production of minerals, or for or incidental to the operation of those tanks, stations and structures

F) For a pipeline (s.12(1)(c) of the Act)

i) for one pipeline (in the right of way):

for or incidental to the construction, operation or removal of a pipeline

ii) for two pipelines (in the right of way):

for or incidental to the construction, operation or removal of two pipelines

G) For a power transmission line (s.12(1)(d) of the Act)

for or incidental to the construction, operation or removal of a power transmission line

H) For a telephone line (s. 12(1)(e) of the Act)

for or incidental to the construction, operation or removal of a telephone line

I) Mine (s.12(1)(a) & (b) of the Act)

for the removal of minerals contained in or underlying the surface of that land or for or incidental to any mining operations, and for the construction of tanks, stations and structures for or in connection with a mining operation, or the production of minerals, or for or incidental to the operation of those tanks, stations and structures.

J) For Oil Sands Operations

K) For a Conservation Scheme

L) For Reclamation under the EPEA

M) For Injection of Captured Carbon Dioxide
