### Personal overview/ Professional philosophy:

Extensive experience in public and private sectors, including international and multi-party. Patient, pragmatic conflict-resolution style. Completed about 600 mediations and about 50 arbitrations (including tribunals) in recent years, involving engineering, construction, business, labor, lands and resource use, contracts, insurance and oil and gas. Active in Civil Courts Mediation Program, Environmental Appeals Board, Land Use Appeals Board, Municipal Affairs, Law Society of Alberta (lawyer conduct), Better Business Bureau, and in other public and private programs. Believe in timeliness, quality and value for money.

Substantive experience in engineering and environmental programs, and in conflict resolution (mediation and arbitration, including tribunals). Recent experience has included international work, and working with provincial and municipal governments. Good track record of working with the private sector, government agencies and First Nations groups.

### Mediation Experience:

My mediation and facilitating experience ranges from files involving only a few hours (such as mediations I do for the Alberta Civil Courts Program) to cases which require periodic conflict resolution actions over a long period of time (such as multi-year construction projects). I have done numerous mediations involving a municipality as one of the disputants.

### Med/Arb Experience:

Med/Arbs are not common but have value in situations where there are both factual and relationship issues. I have done only two of these, successfully; one involved a farming agreement, another was a municipality/developer conflict.

### Arbitration Experience:

As mentioned above, I have done about 50 of these as solo arbitrator or as part of a tribunal. These have usually been one or two day hearings, the longest one was 14 days.
