- the charter of the cooperative and amendments, certified by a cooperative official or notary public or government official,
- an English translation of Charter, if applicable, certified by a cooperative official or notary public,
- Notice of Attorney for Service/Change of Attorney/Alternative Attorney (Form SA0102), and
- an Alberta Name Search Report (from the NUANS database) on the proposed name, dated not more than 90 days prior to the date the Statement of Registration is received by the Alberta Government.
