The Government of Alberta recognizes that many First Nations people and communities in the province prefer not to describe themselves as Indian/Indian bands. These terms have been used where necessary to reflect their legal meaning in the federal *Indian Act*. Upon approval of this registration, Alberta Treasury Board and Finance will forward to you further information regarding the procedures that must be followed to sell fuel and tobacco products free of provincial tax to eligible Alberta Indians.
