1. Background

The Technology Innovation and Emissions Reduction Regulation is Alberta's new industrial emission reduction system, replacing the Carbon Competitiveness Incentive Regulation January 1, 2020.

The Technology Innovation and Emissions Reduction Regulation allows conventional oil and gas facilities to apply to be designated as an aggregate facility.

These applications are to be submitted through the ETS system as almost all interested parties will have accounts through ETS and ETS is well equipped to handle the anticipated volume of submissions.




