Canada is one of many countries moving away from coal and the federal government has mandated an end to coal-powered electricity generation by 2029. We've heard first-hand the uncertainty that creates for many Alberta families. That's why we've worked with the federal government to allow our coal plants to convert to natural gas produced here in Alberta – and to continue operating past 2029.

These new electricity generation options will ensure coal communities continue to power Alberta, while creating long-term economic opportunities.

We know workers will be affected during the transition – even with new construction and operating jobs in natural-gas generation. We've reached agreements with power companies that ensure they fulfill their obligations to affected employees, including severance and pensions.

We've also appointed an Advisory Panel on Coal Communities to hear from economic development organizations, workers, labour leaders and local governments — to help us understand the challenges and opportunities that come with this transition.

The panel will provide recommendations to support retraining and other opportunities for workers — and to support regional economic development. The Alberta Government will share the panel's feedback this fall.

Working together we can create local plans to build diversified and resilient economies for the future.
