# 2019 Recreation Mangement Report

Red Deer-North Saskatchewan Region

### Bighorn Backcountry Public Land Use Zones (tasks completed)

- Outhouses and related infrastructure maintained. Combination of volunteer work and funding and GOA staff and funding.
- Bighorn Signage program, sign maintenance and replacements, kiosks and Bighorn Backcountry brochures distributed.
- Temporary portable outhouses install for all long weekends at the Bighorn Dam (human waste issues).
- Sub regional planning started for the Wild Horse rustic camping area and the Eagle Lake / James pass trail system.
- New trail development and maintenance completed on the Fire Smart Ecological trail system. Agriculture and Forestry staff and funding.
- Trail monitoring continued with trafx counters and trail cameras.
- GOA staff worked with volunteer groups, trail maintenance and future planning and approvals.
- Trail planning and work was started on the Bighorn Dam trail system. Completion of the work has been delayed due to wet ground conditions. The Bighorn Heritage ATV Society will continue the project in 2020.
- Hummingbird and Bighorn Dam trail systems had trail closures due to wet ground conditions.
- New footbridge was constructed on the Coral Creek trail by the JFR crew.

## Rocky to Nordegg Rail Trail Project

- New trail work was done from the new Shunda bridge at Harlech to Tidewater gas plant was done. Graveling still pending.
- Erosion protection work was installed from Tidewater gas plant to Beaverdam PRA.
- Trail Cameras were installed on the new trail to develop user information.

### Work on Vacant Public Lands Outside the Bighorn Backcountry PLUZs

- New trail planning and development has been started in the Meadows area. Delayed due to wet ground conditions.
- Planning & approvals work has been started for the James Pass bypass trail.
- GOA staff continuing to work with Volunteer clubs outside the Bighorn Backcountry PLUZs.
