## TM88 Instructions

Public Land Disposition for the purpose of these instructions shall be "disposition".

The TM88 form provides record of the transfer of ownership of timber or salvage from a disposition, from buyer to seller, and a form must accompany each and every exchange of ownership of the timber / salvage.

The TM88 form transfers the ownership of the timber or salvage from a disposition, and while not required to accompany each load from the disposition, it <u>does not</u> replace the requirement for a Form TM9 or Forest Products Hauling Record to accompany and identify each load of timber/salvage removed from the disposition.

The TM88 or **Timber / Salvage Ownership Transfer Authority Form** is recognized by the Crown in Right of Alberta as record of ownership transfer, and must be provided, upon request, for inspection by a Forest Officer, an officer of the Royal Canadian Mounted Police, a special constable, a peace officer or any other person authorized for the purpose by the director.

Multiple dispositions may be included on one form TM88; the form must be complete, accurate and legible.

Failure to; accurately complete, retain a record of, or provide the form may be considered a contravention of Timber Management Regulation, and be subject to enforcement action.
