Producers planning on milking cows (*Bos Taurus*) may be required to hold quota as per the Alberta Milk Plan Regulation administered by Alberta Milk. Please contact Alberta Milk at 1-877-361-1231 or 780-453-5942 to determine if quota is required, and as such, you would then be licensed by Alberta Milk.

This Dairy Producer Licence Application is only for producers who have not been allocated a quota under the Alberta Milk Plan Regulation and are exempt from the Regulation if the applicant produces less than 50 litres per day of regulated product (milk), the person ordinarily resides on the same parcel of land on which the production facilities (where the regulated product is produced) are located, and not more than 50 litres per day of the regulated product is produced on the land where the production facilities are located.

The following requirements must be provided to assist in the application approval process:

1. A site plan of the proposed dairy production facility including the milking barn, milk house, and animal housing.
2. An operational plan outlining the equipment and processes to be used. This includes the size and make of the bulk milk tank, and the method of transporting of the milk.
3. The number of animals to be milked at peak milking.
4. A letter of exemption from the Alberta Milk Plan Regulation if you will be milking cows. Dairy producers with less than 50 litres of milk production per day may not be required to hold quota, and therefore would be exempt from the Alberta Milk Plan Regulation. This letter of exemption is obtained from Alberta Milk.
