Graphical Land Information Management Planning System (GLIMPS) Data files – Details

Files are produced from the Graphical Land Information Management Planning System (GLIMPS) in CSV (comma separated value) format.

The cost for the complete data file for surface is \$1250.00 and is accessed through the <u>Electronic Transfer</u> <u>System (ETS)</u> with a secured password.

Daily update files in the same format as the complete data files are also available at a cost of \$650.00 per month. The daily update files include all updates performed on GLIMPS on a particular day. The daily update files include the date within the file name and are retained on the ETS site for a period of 30 days. Prior to utilizing the daily update file the requestor's database must be loaded with a complete data file.

At the end of each month, two zip files of surface data are produced.
