Note to Grant Recipients

Contractors who have been approved for an SRP grant must submit invoicing and payment requests to receive their interim and final grant payments. These Invoice and Reporting Guidelines explain the details of submitting payment requests using the online SRP application site – known as the Electronic Transfer System (ETS).

- You can only submit **one** interim and **one** final payment request for each grant, so please ensure that all related work is complete with documentation when you make these requests.
- You are now able to skip making an interim payment request for completed projects by choosing to submit only one final payment request per grant application. This is a permanent decision that is not reversible in ETS.

Invoice and Reporting Introduction

The original program design assumed that the entire scope of site rehabilitation work in an SRP agreement receiving grant funds would be completed (the "Completed Scope of Work"), and eligible to receive the maximum total approved grant amount. Since then, ETS enhancements have been made to accommodate additional scenarios as per the following definitions:

- Completed Scope of Work the entire scope of work associated with the infrastructure site IDs and work activities (infrastructure/activities) outlined in the SRP grant agreement must be completed.
- Reduced Scope of Work a payment request is considered to have a reduced scope of work if the following two conditions are met:
 - Zero per cent scope of work is completed on some of the infrastructure site IDs outlined in the SRP grant agreement (i.e. project work has not or will never be started on these infrastructure site IDs).
 - The rest of the infrastructure site IDs in the SRP grant agreement have or will have a hundred per cent of the work completed by the final invoice stage.
- Partial Work Completed the entire scope of work is not completed on one or more of the infrastructure site IDs and work activities outlined in the SRP grant agreement at the final invoice stage. A payment request will be considered to have partial work completed for grant period 5 onwards if any of the following two conditions are met:
 - The scope of work is completed on more than fifty per cent of infrastructure IDs in the SRP grant agreement, and the rest of the infrastructure site IDs only have partial work completed, or
 - The scope of work is completed on more than fifty per cent of infrastructure IDs in the SRP grant agreement, and partial work is completed on some of the remaining infrastructure IDs and zero per cent scope of work is completed on one or more of the remaining infrastructure IDs in the SRP grant agreement.

Single asset applications with a single work activity will only be considered for partial work scope payment as an exception on a case-by-case basis.

Invoicing and Payment Principles

The following criteria and requirements apply when receiving payment for the above scenarios.

- In order for you to receive the maximum total approved grant, including the final grant payment, the entire scope of site rehabilitation work in the SRP grant agreement must be completed.
 - SRP grant funding is approved specific to the scope of work and activity type on each site in an application. Schedule A of the SRP grant agreement details the amount approved per infrastructure site ID and activity type, as well as the

maximum approved amounts for the three grant payments and the total approved grant.

- You will be eligible to receive all three instalment amounts for the approved grant when the entire scope of site rehabilitation work in the SRP grant agreement is complete subject to all conditions of the grant agreement being met.
 - From application period 3 and subsequent periods, you will see the interim amount approved and final grant payment available for each infrastructure site ID and activity type on the Interim and Final Invoice and Reporting Forms. You are required to request a grant amount for the work in progress for interim invoices, and work completed for final invoices on each infrastructure site ID when submitting a payment request.
 - Interim invoice payment requests cannot exceed the amount approved for each infrastructure site ID – activity type.
 - When submitting your final payment request, you are able to move allocated grant amounts from one infrastructure site ID – activity type combination to another infrastructure site ID – activity type combination so long as the entire scope of work for which grant funding was approved is complete on all infrastructure site IDs.
 - Final payment requests with allocated grant amounts moved between infrastructure site ID – activity types cannot exceed the final grant amount available.
- Applicants are encouraged to ensure that contracts with Licensees cover those costs for work done that exceed the amount offered by an SRP grant. SRP funding is meant to accelerate site abandonment and reclamation work and is not meant to be the only source of funding for work completion.
- Licensees and Contractors are responsible to meet all regulatory requirements for any activity conducted on their sites – whether the work is being funded through an SRP grant or not.
 - The infrastructure and site must be left in a safe and secure condition upon completion of partial work scenarios.
 - The SRP grant agreement must remain in good standing.

- The Licensee/WIP has verified and signed the invoice(s) submitted by you as part of the payment request.
 - While only one interim invoice report and one final invoice report can be submitted in ETS per application, a contractor can upload multiple Licensee signed invoices, if necessary, per interim or final payment request as a single PDF to ETS.
- Circumstances that prevent completion of the entire scope of work as per your SRP grant agreement were unforeseeable and beyond your control.
- The Department must be notified as part of the payment request if any of the approved site rehabilitation work will not be completed so the remainder of the total approved grant amount can be returned to the Licensee's/WIP's allocation or in Period 6, the Community's allocation.
- The Department will consider payment requests for partial work due to unforeseen circumstances but only up to the limit of the interim payment amount per infrastructure site ID – activity type combination where the entire scope of work is not complete. You are not eligible for the final grant payment amount allocated for that particular infrastructure – activity type combination.
 - This means that you are eligible for an interim invoice grant payment per infrastructure site ID – activity type combination of up to 60 to 80 per cent (if municipal taxes paid) of the total approved grant amount in your SRP grant agreement with supporting invoice documentation. A final payment will not be issued for that particular infrastructure site ID – activity type combination.
 - Interim payment requests must be for costs incurred, as long as the costs are reasonable and reasons for not completing the entire project are documented in a separate memo.
 - On-site field operations and physical work must be conducted to be eligible for partial payment.
- You will be required to identify reduced scope of work scenarios at the interim payment stage, if known, and final payment request stages. This will allow for the grant amount allocated to that infrastructure site ID to be returned to the Licensee's, WIP's, or Community's allocation, and the site infrastructure cost reasonability limit to be adjusted accordingly. Error messages will not occur if the same scope of work is applied for in future applications.

- If you identify that work will not proceed on an infrastructure site ID at the interim payment stage this is a permanent declaration and you will not be able to reverse your decision at the final payment request stage.
- If you identify that work will not proceed on an infrastructure site ID, the allocated amount for that infrastructure site ID – activity type combination from the initial grant payment will be deducted from the final grant payment.
 - If final payment is not issued, you will be required to repay the allocated amount for that infrastructure site ID – activity type combination for the first grant payment by sending a cheque made payable to:

Payment Request and Review Process

- Each payment request will be reviewed and compared to application review details such as the number of approved infrastructure site IDs, activity types, approved grant amounts for each infrastructure ID, and the grant instalment amounts.
- The invoice must reference the costs incurred by infrastructure site ID, work activity or service provided, and amount requested.
 - If the information on the invoice (number of assets, infrastructure site IDs, work activity or service provided and payment amount requested) do not match, the payment request will be declined.
- A memo, addressed to the Government of Alberta, must be uploaded with the payment request if site rehabilitation work will not proceed, or be completed on any infrastructure site ID in an SRP grant agreement. The memo should refer to the SRP application reference number and include the following information:
 - An explanation of the partial work completed to date per infrastructure site ID.
 - Rationale for the partial payment amount requested.
 - Reasons for not being able to complete the entire scope of work or project.

- If the work on any infrastructure site ID will not proceed (interim invoice stage) and a final payment request will not be necessary.
- Payment requests for partial work scenarios will be considered for all application periods however, from period 5 onwards, where grant funds were provided for multiple infrastructure site ID applications, at least 50 per cent of the infrastructure site IDs must have the work activities completed.
 - From application period 5 and in subsequent periods, single asset applications with one work activity will only be considered on a case-by-case basis as exceptions. For example, where applicants do not have multiple applications approved within the same period.
- The project data reported in each payment request will be reviewed as this data informs the reporting of program performance measures. It is important that these fields be filled out accurately. See section G under <u>Final Payment Request</u> for further guidance.
 - The number of total hours of work generated on the Final Invoice and Reporting Form is for the entire project or job, and must include the hours reported in the Interim Invoice and Reporting Form.
 - The reporting of the number of abandonments completed means:
 - well abandonment is completed including cut and cap and regulatory submissions, or
 - pipeline segment abandonment work has been completed including regulatory submissions, or
 - facility abandonment work has been completed including regulatory submissions.

You should report "Not Applicable" if the abandonment work for which you received grant funding is completed but does not meet the criteria above (work does not complete the abandonment process).

- The reporting of the number of sites with reclamation completed means that the reclamation process has been completed; however, the site may not be ready for submission of a reclamation certificate application.
 - You should report "Not Applicable" if the progressive reclamation work for which you received grant funding is completed but does not meet the criteria above.

- The reporting of the number of sites with remediation completed means that the entire site and offsite areas, if applicable, have been remediated and a report has been uploaded to AER's OneStop tool.
- In general, you should **not** enter a value and report "**Not Applicable**" if the scope of work that you completed is a step in the abandonment, remediation or reclamation process, and does not require an AER OneStop submission ID.

Invoice and Payment Request Details

The following is required when submitting a payment request:

- A copy of the main invoice and any other supporting invoices (field tickets are not required) from your company addressed to the Licensee for the work completed. An invoice template is available for use on <u>alberta.ca/site-rehabilitation-program-grantinvoicing-and-payment.aspx</u>. A completed example is attached in <u>Appendix E</u> for your reference.
 - The invoice must be signed by the Licensee as verification that costs are reasonable and the work being invoiced is complete. If the OFS contract is with a Working Interest Participant (WIP), the WIP signs the invoice. The required signoff details include:
 - the signer's name and title (can use their stamp from a Professional Regulatory Association in lieu),
 - an actual signature (can be an image of the person's signature), and
 - the date when the invoice was approved.
 - Electronic signatures are acceptable and must include the required items above.
 - The invoice must include the following application details to help cross-reference information:
 - application R number, infrastructure site ID, and associated SRP work activity and cost of services (by infrastructure site ID),
 - the total cost of all services provided on all sites, if the application is for more than one activity/ infrastructure site ID.
 - The invoice must not include ineligible costs such as:

- administration fees, commissions and marketing expenses
- costs of work to prepare for contract bids, grant applications or contracts
- similar costs not directly incurred in relation to eligible closure activities
- overhead-related expenses such as cell phone charges, vehicle purchase payments, insurance payments, liability insurance coverage etc.
- The invoice may include eligible costs such as:
 - materials and supplies for the work
 - wages
 - equipment rentals
 - laboratory analyses
 - project management and supervision costs
 - costs to prepare required reports for the Alberta Energy Regulator (AER)
 - costs to prepare reclamation or remediation certificate applications
 - lease or rental payments for vehicles

For interim invoice reports, keep in mind:

 You can only make an interim payment request up to the Interim Invoice Grant Payment amount listed in your grant agreement (Table 1, Schedule A) in ETS. However, the total amount included on your invoice (which you will upload as a single PDF to ETS) will be for the work completed to date through both the initial grant payment you received, and the interim payment you are requesting. In other words, the total invoice amount provides evidence of all work completed to date, and must be equal to or greater than the initial grant payment and the amount of your interim grant payment request.

For final invoice reports, you will need:

- submission ID numbers from AER's OneStop system when a major closure milestone is achieved such as:
 - o downhole abandonment

- o surface abandonment
- phase 1 ESA report uploaded
- o phase 2 ESA report uploaded
- o remediation report uploaded
- o reclamation certificate application application submitted
- To get these submission ID numbers, the Licensee, or their agent, must enter any reports for completed work into AER's OneStop tool for each stage of closure work. See: <u>https://www1.aer.ca/onestop/</u>
 - At this time, you cannot upload reports to AER's OneStop for progressive reclamation, remediation, or certain abandonment work (steps in the abandonment process preceding downhole and surface abandonment), so a submission ID is not available for final invoicing. Instead:
 - Contractors must upload a Progressive Reclamation Declaration Final Invoice Form, outlining the work completed as part of their SRP contract, along with final invoicing information, in order for the final grant payment to be processed. A template is available for use on <u>alberta.ca/site-</u> <u>rehabilitation-program-grant-invoicing-and-payment.aspx</u>. See sections F and H under <u>Final Payment Request</u> for further instructions on how to submit the form as part of a final payment request.
 - For abandonment work that does not require an AER submission ID (steps in the abandonment process preceding downhole and surface abandonment), enter the number "999999999" into ETS. See sections F and H under <u>Final Payment Reques</u>t for further guidance.
 - For remediation work that does not require an AER submission ID (work steps in the remediation process that does not lead to the site being remediated and a report uploaded to AER's OneStop), enter the number "99999999" into ETS. See sections F and H under <u>Final Payment</u> <u>Request</u> for further guidance.
 - For completed work on unlicensed pipeline segments, enter the number "55555555" into ETS. See section E under <u>Final Payment Reques</u>t for further guidance.

- Abandonment, remediation, and reclamation work activities conducted under an SRP agreement are not GST and carbon tax exempt. However, GST and carbon tax are not eligible for SRP grant funding. For this reason, SRP funding will not cover the GST or carbon tax on an invoice from the Contractor to the Licensee. Do not include these as part of the total amount requested for your interim and final grant payment requests. Contractors will not receive grant funding to cover GST or carbon tax.
 - Applicants and their customers are encouraged to seek advice from their tax advisors about their respective GST obligations, and any other tax obligations under their oil field service contracts.
- Incorrect or untruthful declarations may result in the Licensee's sites no longer being eligible for grants under the SRP. The existing regulatory requirements under the <u>Professional Sign-Off Policy</u> and AER Rules/Directives regarding professional sign-off on remediation and reclamation work apply irrespective of any grants issued under the SRP.
- A glossary of the application statuses an applicant sees in ETS throughout the application workflow is included in <u>Appendix D</u>.

Proof of Sub-contractor Payment

- Prime contractors must provide sufficient evidence that their sub-contractors have been paid in full when submitting invoicing for interim and final grant payment, or prime contractors may voluntarily request that the Department waive this requirement by following the <u>waiver of pre-payment process</u>. When providing proof of sub-contractor payment:
 - Identify each sub-contractor and the amount paid to them. The information provided must relate to the sub-contractor invoices for the specific application R number.
 - Attach proof of payment for all sub-contractors, as part of the invoice and one PDF file, a copy of one of the following:
 - an electronic transfer of funds with a bank statement showing financial institution transaction numbers (NOTE: Remittance advice or internal payment system statements without supporting bank transaction information or statement is not sufficient),
 - a processed/cleared cheque with bank endorsement information on the back of the cheque, or

- a document from the sub-contractor confirming payment receipt. The document must reference their invoice number and amount paid.
- Proof of payment submissions must include contact information for third-party payment providers or financial institutions, as the department may contact them to verify proof of payment.

Waiver of Pre-Payment Requirement

- To request that the Department waive the proof of sub-contractor payment requirement, and provide assurances to all parties involved, you can choose to follow the waiver process described in detail in <u>Appendix F</u>. This waiver process involves completing or collecting three different types of documents and providing them as one PDF invoice file in the ETS for each payment request.
 - Templates for all three documents are available for use on <u>alberta.ca/site-</u> <u>rehabilitation-program-grant-invoicing-and-payment.aspx.</u>
- It is the prime contractor's responsibility to follow the waiver process, compile the documentation, and determine which sub-contractor invoices to submit under this process.

How to Make a Payment Request

- Use your existing <u>Electronic Transfer System</u> (ETS) Site Rehabilitation Program user account to log in to ETS and make a payment request for a particular application.
 - You are able to proceed directly to submitting your one final payment request if you choose to do so – this decision is permanent and not reversible.
 - Your interim payment request must be reviewed and approved by the Department before you can submit a final payment request for the same grant.

You can only submit **one** interim and **one** final payment request for each grant – ETS will not accept multiple payment requests for either interim or final payments. Make sure you have all required documentation to make a full interim or final payment request before submitting.

• Once you have logged in, click on the "Invoice & Reporting" node under the Site Rehabilitation Program folder to submit your payment request.

• Scroll through the pre-populated list of your grant applications or enter the grant application number for which you would like to request interim payment (Figure 1).

- Under column five (Interim Payment Request) click on "View" to fill out the Interim Invoice and Reporting Form. A sample is attached in <u>Appendix A</u> for your reference.
 - To proceed directly to the final payment request for the application, scroll to the bottom of the form and select "Skip Interim Invoice" (Figure 2).

- Sections A to D will be pre-populated with information from the application's grant agreement – the application reference number, project description, grant funding summary, and applicable grant application period. The "First Grant Payment" in Section C: Grant Summary is pre-populated from the Department's payment information.
- In Section E: Sub-Contractor, you are asked to respond whether your company used sub-contractor(s) for the portion of work for which you are submitting costs in this grant payment request. These sub-contractors must be identified in your invoice documentation and the amount paid to them.
- In Section F: Asset Grant Amount, you will see that all the infrastructure site IDs, activities, paid and approved amounts associated with the application are auto-populated (this breakdown of approved grant amounts by asset may not be available for period 1 and 2 grant applications). You must request an interim payment amount for each

infrastructure ID by clicking on the white dot at the far left of the table and then clicking "Update Well Amount Requested" (Figure 4).

- If the work is not going to proceed on that infrastructure site ID (Reduced Scope) click on the white square and you will be required to upload a Memo as per the guidance under <u>Payment Request and Review Process</u>. You will not be able to enter an "Interim Grant Amount Requested". NOTE: Once you identify that work is not going to proceed on an infrastructure site ID and submit your interim payment request, you cannot reverse that decision.
- Enter the "Interim Grant Amount Requested" for that infrastructure site ID and click "Update Well". You will need to complete these steps for each infrastructure site ID that is part of your application. - In Section G: Asset Grant Amount & Activity Completion Report, for period 3 applications and applications for subsequent periods, you will see that all the infrastructure site IDs, activities, paid and approved amounts associated with the application are auto-

populated. You must request a final payment amount for each infrastructure ID by clicking on the white dot at the far left of the table and then clicking "Update Well Amount Requested" (Figure 8).

- Note: If the work completed on some infrastructure site IDs-activities is less costly than the available amount, and the work completed on other infrastructure site IDs-activities is more costly, these costs can be entered up to the final amount available for all infrastructure site IDs-activities listed on the Final Invoice and Reporting Form.

You will see a negative number in "Final Grant Amount Requested" corresponding to the amount of the initial grant payment amount for that infrastructure site ID – activity combination.

Termination Request Review Process

• The Department will review each termination request and will not process them until they have confirmed receipt of the grant payment refund.

- You will receive an email from ETS notifying you whether the Department has approved or declined the termination request.
 - If the termination request is approved, the Province will also sign the Grant Agreement Termination Document. ETS will notify you when your SRP Grant Agreement is terminated, and the signed termination document is available for download.
 - If the termination request is declined, ETS will notify you that the termination request has been declined. The application will return to its previous <u>Application</u> <u>Status in ETS</u>.

Department Initiated Termination Request

Appendix F

Waiver Process for Proof of Sub-contractor Payment

Step 1 – Forbearance Certificates signed by your sub-contractors

- Reach out to your sub-contractors and ask if they will voluntarily sign a Forbearance Certificate certifying that they will not pursue legal action against the Government of Alberta if, following waiver of the pre-payment requirement, you are unable to pay them for the invoiced work.
- A sub-contractor must sign a Forbearance Certificate in order for you to submit an SRP invoice report without proof of payment for that sub-contractor. You do not have to have all sub-contractors listed on an invoice sign the certificate, however only those that sign will be included and paid after your financial institution receives the SRP payment.
 - The regular <u>proof of sub-contractor payment process must be followed</u> for those sub-contractors that do not sign the certificate.
- Include all signed Forbearance Certificates in your invoice submission, attached to the Waiver of Pre-Payment Requirements in Schedule A (Step 2).

<u>Step 2 – Waiver of SRP Pre-Payment Requirement between the prime contractor</u> and the Government of Alberta

- You must complete and sign a Waiver of SRP Pre-Payment Requirement (the "Waiver") for every SRP invoice report submission. The Waiver is between the prime contractor and the Government of Alberta, pursuant to which the Government will waive the sub-contractor pre-payment requirement upon the prime contractor's completion of all conditions present in the Waiver.
 - The Waiver is the "umbrella document" for this transaction. All sub-contractor invoices, forbearance certificates and the direction to pay must be attached as schedules to this Waiver, and the compiled PDF submitted to the SRP with your one PDF invoice report file in the ETS.
 - Upon receipt of the Waiver and other required documents, the Government of Alberta shall pay the grant funding to you, without proof of payment of the sub-contractors.

Step 3 – Direction to Pay set up by the prime contractor with their bank

- You must set up a Direction to Pay (Direction) process with your bank, directing the bank to immediately pay each sub-contractor who has signed a forbearance certificate once the funds are deposited into your account.
 - Complete the Direction form, including the names of sub-contractors; invoice number and amounts to transfer; and the sub-contractor's financial institution information.
 - The financial institution reviews the Direction, and if they agree, provides their acknowledgement.
 - Once executed by you and acknowledged by your financial institution, the Direction must be included in your one PDF invoice file in the ETS.

Step 4 – Invoice Report submission with Waiver Agreement

When you submit a payment request and one PDF invoice report file in the ETS, it must include all required documents and information, attached as schedules to the Waiver:

- A signed Forbearance Certificate from each sub-contractor (Step 1). If a sub-contractor is involved in completing work under multiple applications, a single Forbearance Certificate, listing each application in the Appendix, is acceptable to cover all work for that sub-contractor. A separate Forbearance Certificate is not required for each individual invoice or application. Ensure a copy of the Forbearance Certificate is included with each applicable invoice report.
- Invoices from each sub-contractor detailing the work completed and amount owed under the specific SRP grant agreement.
- A list of sub-contractors involved in the scope of work specific to the SRP grant agreement.
- The Waiver signed by you (Step 2).
 - The Government of Alberta will sign the Waiver and provide you with a copy signed by both parties.
 - The Waiver can include multiple applications but you must submit it with each payment request.
- A signed and bank acknowledged Direction to Pay (Step 3).

• A Direction to Pay is required for each application.

Step 5 – Department review and payment of invoices

- The Department will review the compiled PDF Waiver submission and if approved, pay the prime contractor.
 - It is your responsibility to ensure that the payment request and invoice documentation is accurate and complete, and includes specific information on the sub-contractors and amounts to be paid. Any lack of clarity will result in the SRP declining the payment request.
- Your financial institution will then transfer the funds directly to the sub-contractors' accounts, as detailed in the Direction.
