ORDER PURSUANT TO SECTION 234(1)(a) OF THE ENVIRONMENTAL PROTECTION AND ENHANCEMENT ACT

WHEREAS BOBBY FRED HNATKO, also known as BOB HNATKO, also known as BOBBY HNATKO stands convicted of the following offence contrary to the *Environmental Protection and Enhancement Act*:

On or about July 18, 2016, at or near Westlock or elsewhere, in the Province of Alberta, did provide false or misleading information to the Director pursuant to a requirement under section 198(1)(i) of the *Environmental Protection and Enhancement Act* to provide information,

and did thereby commit an offence, contrary to section 227(b) of the *Environmental Protection and Enhancement Act*.

AND WHEREAS in addition to a fine of \$1,000.00 as against BOBBY FRED HNATKO, also known as BOB HNATKO, also known as BOBBY HNATKO, imposed under the *Environmental Protection and Enhancement Act*, inclusive of victim fine surcharge, and having regard to the nature of the offence and circumstances surrounding its commission;

AND WHEREAS this order is necessary to prevent conduct that may result in the continuation or repetition of the offence;

IT IS HEREBY ORDERED THAT:

1. BOBBY FRED HNATKO, also known as BOB HNATKO, also known as BOBBY HNATKO is prohibited from applying any pesticide, as defined by the *Environmental Protection and Enhancement Act*, from an aircraft for the period of 1 year from the date of this order. A limited exception to this Order will be that BOBBY FRED HNATKO, also known as BOB HNATKO, also known as BOBBY HNATKO, assuming that he follows all federal and provincial legislation regarding the same, is permitted to apply pesticide from an aircraft on land that either Fred Hnatko or Brian Hnatko or T.K.O. Farms Ltd. or Western Air Spray Inc. or Bobby Hnatko or any combination of the foregoing either own or for which they hold a written lease allowing them to farm.

2. BOBBY FRED HNATKO, also known as BOB HNATKO, also known as BOBBY HNATKO is prohibited from owning, holding shares in or acting as director, officer, employee or agent of any corporation or other entity that applies pesticides, as defined in the *Environmental Protection and Enhancement Act*, from aircraft for the period of 1 year from the date of this order.
