The indemnity program of the Law Society of Alberta (LSA) was reorganized out of the Alberta Lawyers Insurance Exchange (ALIEX) and into the Alberta Lawyers Insurance Association (ALIA). Under this reorganization, ALIA would not be subject to any regulation under the Insurance Act (IA) as a result of section 99(3) of the Legal Profession Act (LPA).
