There is no guarantee that you will be issued a letter. All requests for a 204(c) Letter of Support are subject to a service fee except for Alberta Advantage Immigration Program nominees who have a written request from Immigration, Refugees and Citizenship Canada (IRCC) for a 204(c) Letter of Support. The Request for a 204(c) Letter of Support service fee is non-refundable once a request has been submitted to the Alberta Advantage Immigration Program.

To request a 204(c) Letter of Support from the Alberta Advantage Immigration Program complete this form, assemble any supporting documents required proof of fee payment (if applicable), and email them to the program at AAIPOffice@gov.ab.ca. Request forms must be complete and will only be accepted via email.
