#### Personal overview/ Professional philosophy

I graduated from the University of Alberta, articled in Calgary, and have practiced law since 2000. My experience spans three provinces (Alberta, B.C. and Ontario). My experience and values position me to understand not only dispute resolution, but also the complex matters that municipalities face, as well as the importance of an impartial knowledgeable and thorough decision-maker.

### **Arbitration Experience**

In recent years, I have expanded my practice to include arbitration. As a decision-maker, my arbitration experience has primiarily involved procurement matters.
