## Purpose of the Allocation Area Guide

All owners/operators of designated industrial property must review their existing designated industrial property allocation areas and report any allocation changes in their 2024 Assessment Year Request for Information (2024 AY RFI) Return by November 13, 2024.

This guide is to be used as a supplement to your 2024 AY RFI. It provides instructions for determining and reporting the allocation area information required on most 2024 AY RFI Return inventory file spreadsheets. It also identifies when to add records to the 2024 AY RFI Return and how to report designated industrial property located in multiple allocation areas. Allocation areas are described below in the *Terms and Definitions* section.

## What are my responsibilities as a designated industrial property operator?

The 2024 AY RFI is driven by the legislation and the responsibilities of the property's owner or operator. Under the *Municipal Government Act* sections 294, 295(1), and 322, as well as The Lloydminster Charter, all designated industrial property operators in the Province of Alberta and the City of Lloydminster, Saskatchewan are required to provide information about their designated industrial property when requested to do so by the assessor.

The assessor needs very specific information and documentation that are not available from anyone other than the owner/operator. The assessor will make a request for information (RFI) by using a standardized request. Once the request is made, all owners/operators of designated industrial property must report each tax and assessment jurisdiction (allocation area) where their designated industrial property is located, as of October 31, 2024. This reporting is recorded in the RFI inventory file spreadsheets provided with the RFI.

## Terms and definitions

In the 2024 AY RFI allocation area guide:

- a) **2024 AY RFI Return** means a complete inventory file (including copies of the documents to support the original construction costs and the claimed excluded costs pursuant to the 2005 Construction Cost Reporting Guide and any supplementary GIS files) submitted to the assessor in response to the RFI.
- b) **Act** means the *Municipal Government Act* (RSA 2000 Ch M-26).
- c) **Alberta** means the Province of Alberta and the City of Lloydminster, Saskatchewan.
- d) **allocation** area means the administrative land areas defined by the assessor to identify in which municipality, and what geographic area within the municipality, the designated industrial property is located.
- e) **assessment** jurisdiction (AJ) means a geographic area within a tax jurisdiction that may have its own set of tax rules and regulations, typically created by Order in Council such as an annexation.
- f) **assessor** has the meaning given to it in section 284(1)(d) of the *Municipal Government Act*.
- g) **designated industrial property** has the meaning given to it in section 284(1)(f.01) of the *Municipal Government Act*.
- h) **geographic information system** (GIS) means a map-based application such as MapInfo, ESRI or Intergraph and the application's associated spatial data (example: line work style, symbols and geometries).

- i) **Lloydminster Charter** means The Lloydminster Charter (AR 212/2012).
- j) **municipality** has the meaning given to it in section 284(1)(o) of the *Municipal Government Act*.
- k) **operator** has the meaning given to it in the *Municipal Government Act* section 284(1)(p).
- l) **order in council** (OIC) means an order issued by the Lieutenant Governor in Council.
- m) **request for information** (RFI) means the information requested by the assessor pursuant to the *Municipal Government Act* sections 294(1), 295, and 322.
- n) **tax jurisdiction** (TJ) means a geographic area that has its own distinct set of tax rules and regulations, typically a municipality's boundaries.

## General instructions

### What is new for assessment year 2024?

New, updated and expired allocation areas for assessment year 2024 are listed in Tables 1, 2 and 3. This year there are eight (8) new or updated allocation areas (Table 1), six (6) expired allocation areas (Table 2) and no (0) municipal dissolutions (Table 3).

### What is designated industrial property allocation?

Allocation is the process of determining the physical location of your designated industrial property and identifying the allocation area it resides in. The most common allocation area is a tax jurisdiction. When designated industrial property is located in multiple allocation areas, allocation also includes the process of determining the length (or quantity) of the designated industrial property in each allocation area.

Should a municipality have special tax requirements (i.e. to satisfy OIC conditions for annexations or tax sharing) that affects designated industrial property, the assessor must report per special tax requirement area. In such situations, both a tax jurisdiction and an assessment jurisdiction must be reported in your 2024 AY RFI Return.

### How do I report allocation areas in the 2024 AY RFI Return?

To get you started, your 2024 AY RFI inventory file has been pre-populated with the best allocation information (TaxJurID, AsmntJurID, AAName columns) known to the assessor. You must update the pre-populated information with additions, deletions and changes as required to reflect the inventory you own, as of December 31, 2024, and its physical location versus the 2022 allocation area boundaries.

While most previously reported allocations will be unchanged for your 2024 AY RFI Return, designated industrial property in or near changed allocation areas (see tables 1, 2 and 3) need to be reviewed and re-allocated as required.

All operators of designated industrial property, by November 13, 2024, must allocate their designated industrial property to the appropriate 2024 allocation areas as follows:

1. Determine the physical location of each designated industrial property.

GIS inventory records may be the true physical location of your inventory (placement geometry) or they may be the simpler cartographic representation (presentation geometry) found in paper maps. As with paper maps, presentation geometries must be adjusted to correctly allocate your inventory.

Note: Paper maps **may not** accurately represent the location or length of inventory installed. This 'distortion' is necessary to allow people to read inventory line work, symbols and notes in highly congested areas (for example, utility corridors, urban rights-of-way). You must account for this 'distortion' when allocating your inventory, especially when it runs close to (or parallel to) an allocation area boundary.

2. Understand the boundary for each 2024 allocation area by:

- a) loading the ESRI or MapInfo format files (as referenced in your 2024 AY RFI package) into your GIS system. These files are geographic projections with a NAD83 datum.
- b) reviewing the enclosed Adobe files (as referenced in your 2024 AY RFI package). Textual descriptions and map-based interpretations of each OIC area are included. As most allocation areas are identical to an Alberta municipal boundary, maps from the municipality or other official sources can also be used to understand the geographic definitions for the allocation area boundaries in Table 4.
- c) noting allocation areas change over time. Municipalities dissolve and boundaries are redrawn through municipal annexations. See Tables 1, 2 and 3 for a summary of these changes. Review your inventory in the impacted areas and adjust your 2024 AY RFI inventory file spreadsheets as required.
- d) noting some tax jurisdictions may have been subdivided into multiple assessment jurisdictions through an OIC. Inventory that physically resides in these assessment jurisdictions must be reported as such. It is not enough to simply report the tax jurisdiction in these circumstances.

3. Determine the allocation:

- a) Allocate equipment site facilities based on the allocation area for the main entrance of the building, structure or land the inventory is located on.
- b) Each customer site and transmission facility must be examined to determine the allocation area(s) that it resides in. If there is more than one, the length/quantity of the facility must be apportioned for each allocation area.

4. Include the allocation details in your 2024 AY RFI Return:

- a) You must report one record in the 2024 AY RFI inventory file for each allocation area that an item of designated industrial property is located in (whether the allocation area is a jurisdiction that taxes or not); and
- b) Report the allocation area tax jurisdiction (TJ) listed in Table 4, column 3 and if applicable, the assessment jurisdiction (AJ) listed in Table 4, column 4 in the 2024 AY RFI inventory file spreadsheets when requested in the 2024 AY RFI.
