# **Purpose**

This position is responsible for the diagnosis, repair, testing and certification of small engine and related equipment used by the Department. This includes fire equipment, boats, ATVs, snowmobiles, trailers, vehicles and other mechanical equipment.

# **Responsibilities and Activities**

- 1. Maintain and repair fire equipment, boats, ATV's, snowmobiles, trailers, vehicles and other mechanical equipment:
  - Diagnose defective equipment items and make repairs as required to make the item serviceable.
  - Perform testing of fire equipment items to ensure they are within specified standards.
  - After testing, certifies the item is serviceable and is ready for use.



- Provide field support for wildfire operations.
- Test and assess new equipment items and components on an ongoing basis.

# 2. Administrative Responsibilities

- Complete work orders to record the labour, parts and type of repairs done on items certified for use.
- Create parts order lists, stocking and counting of parts and supplies inventories.
- Participate in training sessions for Department staff on the basics of equipment operations and maintenance.
- E-mail management.
- Month-end salary report, expense account and learning account records completion and submission.

# **Scope**

Position services and repairs a variety of small engine and related equipment including fire equipment, boats, ATV's, snowmobiles, trailers, vehicles and other mechanical equipment used by Department staff to conduct their operational programs. Position also repairs and certifies fire equipment items loaned to other agencies when the items are returned to Alberta. Position is critical in supplying serviceable equipment items for fire suppression activities and other Department programs. Properly operating fire equipment is essential to protect department staff and members of the public during wildfire events. The small engine mechanics provide mechanical services to equip over 5000 permanent, seasonal and emergency firefighters. This is an essential support position for the wildfire suppression program and provides valuable support services for other Department programs.

#### **Contacts**

Communication is usually for the purpose of exchanging information with co-workers and supervisor in regards to diagnosing an equipment problem and ordering replacement parts as required.
