**Stream Definition:**

The Correctional Service Worker stream encompasses positions providing a variety of casework, security and offender management services in an adult or young offender centre or a broad range of community based correction programs and services to adult and young offenders in district community corrections offices throughout the province.

The focus of the work is on preparing offenders for return to society and optimizing their chances to assume responsibility of acceptable behaviour. Positions assist and encourage offenders to use services and programs related to their needs for the purpose of developing the abilities and skills necessary to conduct independent law abiding lives.
