- \*\* On-line I-200 courses do not include the requisite group activities and discussions to meet the I-200 in-class prerequisite standard. ICS Canada does not accept on-line 200 as a prerequisite to I-300.

Video-delivery of ICS courses has been approved for the duration of the pandemic. Video-delivery courses including all group activities and discussions are considered equivalent to an in-class offering and may issue ICS Canada certificates for course completion.



# **ICS Alberta Course Prerequisites**

# Effective January 1, 2023



Not all training providers meet ICS Canada and/or ICS Alberta training standards. For a list of approved providers, see the reverse side. On-line I-200 courses may not be accepted by all organizations.

Effective January 1st, 2023, participants will be required to provide a copy of their pre-requisite certificates from approved ICS Canada providers in order to register or attend ICS Canada training in Alberta.

Prerequisites are based on the "ICS Canada Curriculum and Training Standards 2022" available at www.icscanada.ca.

There is a minimum time between I-200 to I-300 and I-300 to I-400 of five months. Instructors are not to accept students under the minimum five months without a written waiver from the Authority Having Jurisdiction.

## TRAIN THE TRAINER COURSES

Instructors are expected to have seen the ICS Canada course before teaching. Those with qualifications other than ICS Canada or on-line I-200 may be required to observe and/or participate in an ICS Canada approved course as a condition for instructor recognition.

Basic Train the Trainer	I-100, I-200 in-class, I-300
Advanced Train the Trainer	I-100, I-200 in-class, I-300, I-400, Basic Train the Trainer or I-200 Train the Trainer
Position-Specific	Advanced Train the Trainer or I-300 TtT (to teach modules) or I-400 TtT (to be Lead Instructor). No position specific Train the Trainer currently exist, but the candidate is expected to have taken the course from an approved provider before applying to become an instructor.
