Purpose

The purpose of this document is to provide an overview of the Pending Registration Queue (PRQ). It lays out what is changing and what is staying the same. It also includes tips to ensure transition is as seamless as possible. In order to assist with the changes we have attached SPIN2 screen shots to show the visible changes once the PRQ is implemented.

Background

- The Land Titles Act was amended to legislate a Pending Registration Queue (PRQ)
- Today, priority on title is guaranteed upon registration of an interest
- The amendment guarantees priority on title upon submission and receipt by Land Titles
- The PRQ allows stakeholders to complete transactions without waiting for registration
- Also allows stakeholders to maintain their priority on title, even if there are minor deficiencies regarding their submission
- Regulation allows the Registrar of Land Titles to remove submissions from the queue and documents to be registered out of order if absolutely necessary
- Reliance on the PRQ to close transactions and release funds is optional

Changes

- Rejection Notices will now be referred to as a "Notice of Deficiency"
- Deficient submissions are required to be returned to LTO within 30 days of a Notice of Deficiency being issued
- Most documents submitted will require input of a Land ID when creating a DRR *see below for exceptions
- Priority is guaranteed upon LTO receipt (ie: the DRR has been barcode scanned and appears in the queue)
- There will be no time sensitive documents that require same day registration, they will be registered in order they are received
- SPIN2 title will now show the interests pending (PRQ) at the bottom of the title, along with the name and contact information for the submitter
- CCTs and Fax Notices options will not exist on the DRR/RR
- Customer Registration Notices and Notice of Deficiencies are free on SPIN2

Documents that do not require a Land ID on DRR

- Letter of Road Abandonment
- Miscellaneous Plans
- Monument Plan
- Monumentation Certificate
- Mortgage Standard Form

What this means

These documents will not show up in the Pending Registration Request Search or on the PRQ Endorsement on the SPIN 2 title. There is a possibility that once your submission is registered one of the above documents could have priority on the title.

What is not changing

- Land IDs entered on the DRR creates the PRQ
- Documents will still be registered in order of receipt
- The process for removing your DRR from LTO or recalling a RR from ALTO

Importance of DRR

- As it is today, the Land ID you enter on the DRR/RR is what populates the queue
- If you make an error on the Land ID when entering it on the DRR it will create a queue on the wrong title and LTO cannot guarantee priority on the title that your document references
- Ensure the document type selected is accurate. Incorrect document type could result in a loss of priority
- Examiners will not compare document Land IDs to DRR
- DRR accountability is solely the responsibility of the submitter

Tips

- Double check your DRR/RR before submitting to LTO
- If there is a competing interest in the PRQ contact the submitter. If information provided is N/A contact LTO
- Enter a last registration number on the DRR/RR
- Keep track of original Notice of Deficiency date, so your DRR does not expire
- Check the PRQ or the Pending Registration Request Search to ensure your DRR was received by LTO, contact LTO if was not received within 2 hours of submission

Next Steps

- SPIN2 technology will be updated for PRQ on March 28
- PRQ will be officially operational once LTO is examining work submitted on April 1

Changes you can see (Examples Below)

<u>DRR</u>

- Area for Fax number removed
- Land ID column added
- New disclaimer message regarding PRQ
- No ability to request CCTs

Certificate of Title

- Pending Registration Queue at the bottom of the title
- It will show the date a DRR was received, document type and submitter contact information

My Registration Information

- Will be accessible from the DRR screen
- DRRs will remain listed until they are purged from SPIN2
- Customer Registration Notices and Notice of Deficiency can be ordered free of charge

Pending Registration Request Search

- Will only show DRRs that are active in the PRQ
- Status will either be received or deficient
