I. **Decisions**

To comply with the requirements of the Access to Motor Vehicle Information Regulation (AMVIR) AR 140/2003, as amended, and to further strengthen, clarify, and manage the disclosure of personal information from Alberta's Motor Vehicle Electronic System (MOVES), the Registrar of Motor Vehicle Services (the "Registrar") decides to amend the Registrar's Decisions: Notification 04/2020 as follows:

- 1. Replace the following text in section 6. Specialized Business Functions MVIPs:
- B. **Operator (Driver) Licensing Information SBF-RR MVIPs:** None.

with the following text:

- **Operator (Driver) Licensing Information SBF-RR MVIPs:** B. SBF-RR OI-DMIS: Operator (Driver) Information, Driver's Licensing Status for the Driver Management Information System
- 2. Append at the end of section 7 the following text describing a new MVIP:

7.8. SBF-RR OI-DMIS: Operator (Driver) Information, Driver's Licensing Status for **GoA Driver Management Information System**

This type of SBF-RR MVIP uses the driver's licence number and date of birth to answer the question: "What is the current licensing status of a Government of Alberta Employee allowed to drive a Government of Alberta vehicle?" The main use of this type of MVIP is to confirm in real time the driver's licensing status and to update the Driver Management Information System (DMIS) in the Fleet Safety Office.

Search Criteria

Classification: Public

- An OL number for the registered owner (the driver) of an Alberta Operator's Licence.
- The Date of Birth of the driver

This type of SBF-RR MVIP provides current information on MOVES as of the Search PIT.
