# Religious Societies' Land Act Sample Resolution

To change your religious society's name, constitution, or by-laws, your society must pass a resolution. When your resolution is passed, it must then be filed with Service Alberta, Registries. This fact sheet shows you what is required in a resolution and explains how your resolution should be filed.

## 1. Name of organization and date of meeting.

Identify the name of your organization and the date you met to discuss the changes to your society.

#### 2. Changes made.

Clearly explain the changes made to your society's name, constitution, or by-laws.

## 3. Witnesses' signatures and date signed.

Ensure that the resolution is signed by the president or chairperson as well as the secretary or clerk.

### Filing Your Resolution

To change your society's name, constitution, or by-laws, your religious society must send the information outlined below to Service Alberta, Registries. There is no fee to file these changes.

### Changing your religious society's name?

Send the following to Service Alberta, Registries.

- Two (2) copies of the resolution that changes your religious society's name.
- One (1) copy of a current Alberta Name Search Report showing the proposed name of the society. This is a six-page report that lists names that are the same as or similar to the one your have chosen. This report will help determine if your proposed name meets the requirements of the *Religious Societies' Land Act*.

The Alberta Name Search Report can be purchased from one of the province's search houses. A list of Alberta search houses can be accessed on the NUANS website <a href="https://www.nuans.com">www.nuans.com</a> or in the Yellow Pages under "Searchers of Records".

### Changing your religious society's constitution or by-laws?

• Two (2) copies of the resolution changing your religious society's constitution or by-laws.
