Throughout Alberta, with a focus on Northern and Southern Alberta (i.e. Fort McMurray, Slave Lake, Lac La Biche, Lethbridge, Medicine Hat)

#### Overview:

Alberta Transportation seeks to provide a safe and efficient transportation system to support Alberta's economic, social and environmental vitality. One of the areas to facilitate this is the Third Party Auditor (TPA) Program.

The TPA program ensures commercial carriers are compliant with Alberta Transportation's regulations, federal requirements and National Safety Code (NSC) Standards.

Third Party Auditors are certified by Alberta Transportation to conduct NSC audits and New Carrier Compliance Reviews (NCCR) in accordance with the federal *Motor Vehicle Transport Act* and Alberta's *Traffic Safety Act*.

TPAs provide quality customer service to Alberta's commercial carriers, while conducting NSC audits and NCCR impartially, and in accordance with Alberta Transportation's requirements.

# **Key Accountabilities:**

- Delivery of NSC audits and New Carrier Compliance Reviews (NCCR) in a timely and consistent manner for Alberta Transportation, as per auditing guidelines.
- Promoting and representing the values of Alberta Transportation (Respect, Integrity, Accountability, and Excellence).

- Agility Ability to work under pressure and adapt to change in a fast-paced environment
- Creative Problem Solving Ability to deescalate stressful situations, or managing challenging clients

- Minimum education High School Diploma, G.E.D. or equivalent
- Certificate of Incorporation or equivalent if not incorporated in Alberta
- Appropriate commercial or business insurance
- Experience handling confidential, sensitive or personal information
- Fluency in English (written and spoken) is essential
- Strong keyboarding skills and the ability to multi-task (typing while talking to clients)
- Knowledge of Internet Explorer and MS office products

- Training or recent experience in conflict resolution and de-escalation techniques
- Experience delivering programs on behalf of government agencies
- Previous government experience
