**Design Review Deliverable Summary and Checklist:**

This document is to be completed by the Consultant for Alberta Infrastructure projects that require a Design Review by Technical Services Branch. The intent of the checklist is to ensure the Consultant has submitted all required documentation by phase and by discipline. This checklist will allow Project Managers to confirm that submissions meet the expectations of each phase before they are forwarded to TSB for review.

**Sample Design Report Table of Contents and Design Development Drawing Expectations:**

These documents are offered as a reference for the information of Project Managers, Design Teams, and other stakeholders. The Sample Table of Contents consolidates the major elements that comprise a typical Schematic Design and Design Development report and can be adapted to suit any building typology. Following the Sample Table of Contents, a list of Design Development Drawing Expectations is provided. This document presents the information typically expected in the Design Development drawing submission.

*Note that these documents supplement, but do not replace, the requirements or obligations in the Owner’s Consultant Agreement, documents such as the Canadian Handbook of Practice for Architects, or those found elsewhere in the Technical Design Requirements for Alberta Infrastructure Projects (TDR).*
