

- Alberta GHGenius Index to Sheets in the Spreadsheet & (XLSM, 8 MB) The Alberta GHGenius Model is the most current version of the spreadsheet-based modelling tool referred to in the Renewable Fuels Greenhouse Gas Emissions Eligibility Standard. It is used by renewable fuel industry stakeholders to calculate GHG emissions for the life cycles of fuels.
- <u>Renewable Alcohol and Bio-Based Diesel Validation Certificate</u> J, (XLSX, 69 KB)
 To be completed annually by a qualified validator to confirm eligible renewable alcohol or bio-based diesel has been produced according to the Lookup Table for Established
 Pathways in Appendix 1 of the emissions standard.

 <u>Consolidated Fuel Supplier, Renewable Fuel Provider and Approved Contributor</u> <u>Compliance Report</u>, <u>4</u>, (XLSM, 126 KB)
 According to the RFS Regulation, all parties defined as 'Fuel Suppliers', 'Renewable Fuel Providers' or 'Approved Contributors' must submit annual compliance reports according to sections 10, 11 and 12 of the regulation.



LEARNINGS & ISSUES UNDER CONSIDERATION



• Declarations are required from the RFP identified in the validation certificate:



- RFP can be either producer or importer of fuel according to RFS Regulation
 - If importer, then this entity assumes all responsibility

Section 8 - Validation Certificate Confirmation

• Example of Format:

I, Mr/Mrs/Ms PQR ,as a representative of the renewable fuel provider XYZ Biofuels, hereby declare that the renewable fuels supplied in the 2023 RFS compliance year were produced in a manner that is consistent with the processes and feedstocks that are set out in the validations with reference numbers XXXYYY123, ZXXXTY456 and WWWZCX789.

- RFP to send directly by email to our office on or before March 31 of year following compliance year
- AC/FS to provide copy of RFP declaration as part of compliance reporting on or before March 31 of year following compliance year

NOTIONAL TRANSFERS – FS & AC

- Legal transaction under the RFS involving 2 parties
- All the details (dates, validation reference numbers, volumes, etc.) need to match exactly in the compliance reports submitted by the 2 parties
- There may be multiple notional transfers for the same fuel on different dates. These cannot be aggregated!

NOTIONAL TRANSFERS – FS & AC

• We strongly encourage all parties to confirm exact agreement for notional transfer details prior to submission to our office



AGGREGATED DATA – RFP, FS & AC

 We strongly recommend information related to shipments of renewable fuels of the same fuel type (e.g. E95) be aggregated for a given entity.
