That Scott Sproule did:

Count 1: On or between the 1st day of September, 2020 and the 22nd day of October, 2021, both dates inclusive, at or near Hussar, in the Province of Alberta, did commence or continue an activity except under an approval or as otherwise authorized by the Water Act, contrary to section 142(1)(h) of the Water Act, evidence of the offence having first come to the attention of the Director on October 5, 2021.

Count 2: On or between the 1st day of September, 2020 and the 22nd day of October, 2021, both dates inclusive, at or near Hussar, in the Province of Alberta, did commence, continue or carry out an activity referred to in section 3 of the Water (Ministerial) Regulation without providing notice to the Director in accordance with section 4(1) or 4(2) of the Water (Ministerial) Regulation of the intention to commence the activity, contrary to section 4(3) of the Water (Ministerial) Regulation and did thereby commit an offence contrary to section 2(1)(a) of the Water (Offences and Penalties) Regulation, evidence of the offence having first come to the attention of the Director on October 5, 2021.

Count 3: On or between the 1st day of September, 2020 and the 22nd day of October, 2021, both dates inclusive, at or near Hussar, in the Province of Alberta, did fail to provide notice to the Director at least 14 calendar days prior to commencing, continuing or carrying out works unless otherwise specified in writing by the Director contrary to section 3(1) of the Code of Practice for Watercourse Crossings and did thereby commit an offence contrary to section 2(2) of the Water (Offences and Penalties) Regulation, evidence of the offence having first come to the attention of the Director on October 5, 2021.

Count 4: On or between the 1st day of September, 2020 and the 22nd day of October, 2021, both dates inclusive, at or near Hussar, in the Province of Alberta, did fail to prepare and complete a plan for a works at least 14 days before a works is carried out contrary to section 7 of the Code of Practice for Watercourse Crossings and did thereby commit an offence contrary to section 2(2) of the Water (Offences and Penalties) Regulation, evidence of the offence having first come to the attention of the Director on October 5, 2021.
