I, _____ in submitting this bid (the "bid") to Alberta Forestry and Parks for the timber described in the timber disposition indicated in the table above and in response to the Public Notice of Commercial Timber Permits for Sale by Sealed Tender made by Alberta Forestry and Parks do hereby make the following statements that I certify to be true and accurate.

As a bidder whom is an individual:

1. I am at least 18 years of age; and
2. I have resided in Alberta at least 6 months preceding this tender; and
3. I am not in default under the *Forests Act* or any regulations under the Act.

As a bidder whom is a corporation:

1. The corporation is not in default of the *Forests Act* or any regulations under this Act; and
2. The person signing this form on behalf of the corporation has the authority to bind the corporation.

As a bidder whom is an individual or corporation:

1. I have understand the deadlines and consequences of missing the deadlines outlined in the public notice; and

Independent Bid Declaration:

2. I understand that the accompanying bid will be disqualified if this sealed tender bid form is found not to be true and accurate; and
3. I have arrived at the accompanying sealed tender bid independently from and without consultation, communication, agreement or arrangement with, any competitor¹; and
4. I have not been in consultation, communication, agreement or arrangement with any competitor regarding:
 - a. prices,
 - b. methods, factors or formulas used to calculate prices,
 - c. the intention or decision to submit, or not to submit, the bid or
 - d. the submission of a bid which does not meet the specifications of the commercial timber permit sale; and
5. I have not had any consultation, communication, agreement or arrangement with any competitor regarding the quality, quantity, specifications or delivery particulars of the products or services to which the commercial timber permit sale relates; and
6. I will not disclose directly or indirectly the terms of the accompanying sealed tender bid to any competitor, prior to the date and time of the official sealed tender bid opening, or at the awarding of the timber permit, whichever comes first, or the time that the sealed tender bid is made, unless otherwise required by law.
