

# Head tax permit application

This application should be used when applying for an opportunity to temporarily graze on public land.

The submission of an application does not grant the applicant any authority to use the land until written authorization has been issued by the department.

Grazing use must be for livestock owned solely by the applicant(s). Proof of ownership may be requested. Head Tax permits can be issued for up to a 12-month term and are not renewable or assignable.

**Application Fee \$10+\$0.50 GST. Grazing fees will be due payable if the authorization is issued.**

Completed applications and the application fee are to be returned to the local Rangeland Agrologist. You can find the local agrologist at [Land Management - Contacts](#).
