In consideration of the recognition of the Artwork being featured in Alberta Health's Indigenous Health Division ("**IHD**") documents and reports, which I acknowledge is good, valuable, and sufficient consideration, I agree as follows:

- 1. To hereby release and fully and forever discharge His Majesty the King in Right of Alberta (the "**Province**"), its Ministers, employees, agents, contractors, insurers, and sponsors and each of their respective heirs, executors, representatives, successors, administrators, and assigns (the "**Releasees**") of and from any and all proceedings, claims, actions, causes of action, demands, losses, damages, costs, expenses, bonds, suits, and covenants of every nature and kind whatsoever whether at law, in equity or by statute which I, the Releasor, my heirs, executors, representatives, successors, administrators, or assigns may have had, now have or may have, but for the execution of this release, by reason of, related to, arising out of, or in any way connected with the recognition of my artwork by the Province as part of the Call for Art.
- 2. To hereby waive any right of inspection or approval of my biographical or the uses to which biographical information may be put. I acknowledge that the Province will rely on this permission potentially at substantial cost to the Province, and hereby agree not to assert any claim of any nature whatsoever against anyone in relation to the exercise of the permissions granted hereunder. I hereby release the Province from any claims that may arise from these uses, including without limitation: claims of defamation or invasion of privacy, or of infringement of moral rights or rights of publicity or copyright.
- 3. To indemnify the Releasees against any loss, damage, or expense, including legal fees on a full indemnity basis, that any of the Releasees may suffer or incur as a result of any non-compliance by me with any of the Call for Art Guidelines or participation in the Call for Art and/or in connection with the recognition, exercise, or the use of the Artwork in any publication created by the Province.
- 4. To grant to the Province, its affiliated organizations and each of their agents and representatives and marketing partners, the right to print, publish, broadcast, and use worldwide in any media now known or hereafter developed at any time, the Artwork and my name, social media handle, likeness, portrait, picture, photograph, voice, video-camera footage, and biographical information (name, Nation/Community) as is or as may be edited by the Province, as news or information and for advertising promotional



purposes without any compensation or review by me. I grant these pieces of data and multimedia, as well as my Artwork, to be used an unlimited number of times in perpetuity, without additional compensation, for publishing, distributing, advertising and promotional purposes in connection with the Call for Art.

5. To grant the province a perpetual, irrevocable, worldwide, fully paid, royalty-free, assignable, non-exclusive license to use, reproduce, publish, and distribute the Artwork in any format now known or hereinafter devised, along with the right to sublicense, without limitation, all such rights to the Materials.

I acknowledge that there will be no monetary compensation for the submission or use of the Artwork in any of the Releasee's materials.
