

Sec 32 - Release of Michael Christopher DELMAS

In accordance with Section 32 of the Freedom of Information and Protection of Privacy Act of Alberta, the Medicine Hat Police Service is issuing the following public information and warning with regards to the release of an inmate into the Medicine Hat area. On March 26, 2014, Michael Christopher DELMAS, 30 years of age, will begin residing in Medicine Hat after having served a federal term of 4 years' incarceration for the following offences;

Two charges of Sexual Interference
Two charges of Sexual Assault

Michael DELMAS has a pattern of deviant sexual behaviour which includes offences that cause physical and psychological harm and is viewed by the Correctional Services of Canada and the Medicine Hat Police Service as an untreated offender. Michael DELMAS is described as follows:

Height: 5 ft 11 inches Complexion: Medium

Mr. DELMAS has served his entire sentence and therefore has no pre-release or parole conditions. However, MHPS applied for a Peace bond with strict conditions to be applied to Mr. DELMA's release. As such, Michael DELMAS has entered into a Recognizance before a Judge of the Provincial Court of Alberta, which now requires him to abide by several conditions. The Medicine Hat Police Service will be monitoring his compliance with these conditions:

1. *WITHIN 24 HOURS OF YOUR RELEASE FROM CUSTODY, REPORT TO THE SERGEANT OF THE PRIORITY STREET CRIMES UNIT (OR THEIR DESIGNATE) IN PERSON TO THE MEDICINE HAT POLICE SERVICE AT 884 2ND STREET S.E, MEDICINE HAT, ALBERTA AND SUBMIT TO AN UPDATED PHOTO.*
2. *REPORT WITHIN TWO DAYS OF RELEASE FROM CURRENT SENTENCE/CUSTODY, AND THEN AS DIRECTED TO THE MEDICINE HAT PROBATION OFFICE AT 830 2 STREET S.E., MEDICINE HAT, AB.*
3. *RESIDE IN A RESIDENCE (THE "APPROVED RESIDENCE") APPROVED BY THE MEDICINE HAT PROBATION OFFICE. YOU WILL PROVIDE THE STREET ADDRESS OF THE APPROVED*

RESIDENCE AND NOT CHANGE YOUR APPROVED RESIDENCE WITHOUT THE PRIOR WRITTEN PERMISSION OF THE MEDICINE HAT PROBATION OFFICER.

- 4. IN THE EVENT THAT YOU CHANGE YOUR APPEARANCE, (HAIR, COLOR, HAIR STYLE, TATTOOS, ETC.) ALLOW THE SERGEANT OF THE PRIORITY STREET CRIMES UNIT (OR THEIR DESIGNATE) TO OBTAIN AN UPDATED PHOTO OF YOU.*
- 5. YOU SHALL MAKE NO ATTEMPT TO COMMUNICATE, DIRECTLY OR INDIRECTLY WITH ANY OF YOUR PAST VICTIMS OR FAMILY MEMBERS OF THE VICTIMS IN THE CASE IN WHICH YOU WERE CONVICTED. THE EXCEPTION BEING, VICTIM/OFFENDER MEDIATION THROUGH CORRECTIONAL SERVICE CANADA WITH PRIOR NOTIFICATION TO THE POLICE SERVICE IN THE JURISDICTION WHERE YOU WILL BE RESIDING.*
- 6. YOU SHALL HAVE NO COMMUNICATION WITH ANY PERSON UNDER THE AGE OF 16 YEARS OF AGE UNLESS IN THE IMMEDIATE PRESENCE OF A RESPONSIBLE ADULT.*
- 7. YOU SHALL NOT ATTEND ANY PUBLIC PARK OR PUBLIC SWIMMING AREA WHERE PERSONS UNDER THE AGE OF 16 YEARS ARE PRESENT OR CAN REASONABLE BE EXPECTED TO BE PRESENT, OR A DAYCARE CENTRE, SCHOOLGROUND, OR PLAYGROUND EXCEPT IN THE IMMEDIATE AND CONTINUOUS PRESENCE OF A PERSON OLDER THAN 21 YEARS OF AGE.*

After careful deliberation and consideration of all related issues, including community safety and the privacy concerns of the offender, the Medicine Hat Police Service has issued this notification of the release of Mr. DELMAS.
