STUDENT SCREENING			
I understand that the student application will be screened by the NADB and Alberta Advanced Education based on the following:			
<ul style="list-style-type: none"> • Students cannot receive an NADB Bursary and a Partnerships Bursary, or multiple Partnerships Bursaries exceeding \$3,500 in NADB funds during the same academic year (maximum \$1,750 for half year of study). • Students must not be in default of a provincial student loan. • Students must have an arm's length relationship to the sponsor. The student must not be related to the sponsor, and selection of the student is completed through impartial means. Please call the NADB for clarification of "arm's length". 			
RETURN SERVICE COMMITMENT			
I understand that every student selected to receive a Partnerships Bursary must sign a return service contract which commits the student to live and work in northern Alberta upon graduation. Return service is one full-time month of employment (or equivalent) for each \$500 of total bursary support, for example: 12 full-time months for a combined \$7,000 bursary. Alberta Advanced Education will sign a contract with all bursary recipients. Sponsors may also sign a contract with the student for employment with the sponsor.

SPONSOR AUTHORIZATION
