Instructions Dispensing With Consent to Change a Child's Name

Before you Begin:

- These forms are not to be used to ask the court to change your child's name. The change of name application is made through an Alberta Registries Office. You can discuss the paperwork and fees to make a change of name application with the staff at an Alberta Registries Office.
- In order to change a child's name, you must have the consent of both parents named on the child's birth registration and any other guardians of the child, unless the court orders that a person's consent is not required. Before starting your court application you should speak to the staff at an Alberta Registries office to confirm whether or not you require an order dispensing with someone's consent.
- You will use the forms in this package to ask the Court for an order dispensing with the consent of a person whose consent is required for you to change your child's name.
- You cannot use this package to get an order changing information about a parent on a child's birth registration or birth certificate. If you want to change information about a parent on the child's birth registration, and the other parent is not consenting you will need to make a different Court application.

Fill in the Affidavit form

- Follow the instructions on the form and in the "Making a Court Application" booklet.
- This form has been prepared with the information that the court is likely to want to see. You can, if you wish, change the content of the form to set out the information in a way that you think is best. If you type up your own Affidavit, it cannot be longer than 5 pages (or 8 pages if you are setting your matter for an afternoon Special).
- All of the documents that you want the judge to see must be written about in the Affidavit and attached as exhibits to the Affidavit.
- You cannot have more than 40 pages of exhibits to your Affidavit, unless you get permission from a judge. If you must have more than 40 pages, ask us how to apply for permission.

Tip:

The Affidavit includes paragraphs to use if you do not want to advertise the change of name in the Alberta Gazette. Fill these paragraphs in only if you have a reason not to advertise.

Note:

- When you file your application with the Court of King's Bench Chamber's Clerks, they will charge you a \$250.00 filing fee for filing this application.
- You must give the Respondent(s) and the Registrar of Vital Statistics 10 or more days notice of your application. If you are serving the Registrar of Vital Statistics by recorded mail, the documents are not considered to be served until someone signs to acknowledge receipt of the documents or until 7 days after the recorded mail is sent, whichever occurs first. Keep this in mind when you are selecting your Court date.

Serve the other parent and guardian(s) and the Registrar of Vital Statistics with copies of your Originating Application and Affidavit
