



## **Viability Review Process**



#### What is a viability review?

A **viability review** is an objective review of a municipality's governance, finances, infrastructure, and services that provides options on how the community can become viable in the future.



#### This viability review will:

Engage residents, electors, and the County of Wetaskiwin

Focus on solutions to enable Ma-Me-O Beach to be viable over the long-term

Include recommendations for long-term viability from councillors and administrators of the summer village and county, and representatives of five municipal associations

Move Ma-Me-O Beach beyond the status quo

#### How do viability reviews relate to dissolution?


#### Dissolution

 Restructuring process where a municipality is unincorporated and becomes a hamlet in the neighbouring municipality.

#### **Viability Review**

- Before a municipality is dissolved, the Minister must undertake a viability review that:
  - Reviews a municipality's community, governance, administration, services, finances, and infrastructure.
  - Develops options for long-term viability in a Viability Review Report.
- Dissolution is one of the options considered.

#### **Municipal Affairs**

- Leads the viability review process
- Informs residents and electors of events
- Hosts public information sessions
- Writes the viability review report
- Conducts the vote of electors





#### **Summer Village and County**


- Complete an infrastructure audit (summer village)
- Provide information about municipal operations
- Assist with communications to residents and electors

## What are the options for the long-term viability of Ma-Me-O Beach?


Option 1 
Ma-Me-O Beach remains incorporated; and
Council takes action to ensure a viable future.

**Option 2** - Ma-Me-O Beach dissolves and becomes a hamlet in the County of Wetaskiwin.

## Alberta Community Partnership (ACP) funding

During a viability review:

- Funding to assist the review municipality with an infrastructure audit.
- Minister approved Ma-Me-O Beach's request for the maximum amount of \$120,000.

If dissolution occurs, the County of Wetaskiwin would be eligible to apply for post-restructuring funding based on population of the SV:

- 1. Transitional Stream to integrate the summer village's governance, administration, and legislation into those of the county \$181,000
- 2. Infrastructure/Debt Servicing (non-utility debt) \$743.000

Total of \$924,000






