Resolution 231017-03

The September 12, 2023, Regular Council Meeting Minutes were not revised as directed in my OA Report which directed that:

I allow Resolution 230912-28 with the addition that "to provide infill residential development standards" is also replaced so that the preamble to Bylaw 023-23 is coherent.

The September 12, 2023, Regular Council Meeting Minutes do not show this revision to Resolution 230912-28. As such, I disallow Resolution 231017-03 and direct that Council approve the September 12, 2023, Regular Council Meeting Minutes which have been revised in accordance with my report.

Resolution 231017-04

This Resolution is duplicative of Resolution 231017-33. It does not make sense that Council would pass a Resolution approving a settlement prior to discussing it in camera as Agenda Item No. 10.2. I would find that such an action would be an improvident action by Council. This appears to be an error in the meeting minutes.

I do not allow this Resolution but do allow Resolution 231017-33 which was passed after Council came out of in camera having addressed Agenda Item 10.2.

Resolution 231017-15

I note that Resolution 231017-15 and Resolution 231017-16 are not on the Agenda. Nor were they added to the Agenda pursuant to sections 6.2 and 6.3 of the Procedure Bylaw. As such, I have disallowed both Resolutions.

Moreover, there is no basis given for why Council can demand an individual councillor provide all text messages from his personal electronic device to "third party legal counsel MJM LLP Jeff Moroz" (I note, I am unclear on what basis Mr. Moroz is being described as a "third party". I understand he is acting for the City in a judicial review matter that has been filed).

I am troubled by Resolution 231017-16 as it appears Council is attempting to address an issue which should properly be addressed as part of the Code of Conduct Bylaw. Council can amend the Code of Conduct Bylaw if it chooses to do so. It cannot amend the Code of Conduct by resolution.

As noted above, Resolution 231017-16 was not properly added to the Agenda. I disallow Resolution 231017-16.
