





- I, Doug Lagore, have been appointed Official Administrator of the City of Chestermere (the "City") by the Minister of Municipal Affairs pursuant to Ministerial Order MSD082/22. My appointment was extended to March 31, 2023 by Ministerial Order MSD008/23 and further extended to December 31, 2023 by Ministerial Order MSD022/23. Below are my reasons in respect of the following resolutions:
 - Resolution #231128-04
 - Resolution #231128-05
 - Resolution #231128-07 to Resolution #231138-14

I note that pursuant to Ministerial Order MSD:076/23, the Minister of Municipal Affairs has suspended Ministerial Order MSD022/23. My decision in respect of the resolutions passed at the November 28, 2023 Council Meeting was issued on November 30, 2023, prior to Ministerial Order MSD:076/23. The below are my reasons for my decision of November 30, 2023.

I have commented extensively on Resolution #231031-13 and #231031-25 in my report on the October 31, 2023 Council Meeting Minutes.

My concerns have not been addressed by Resolutions #231128-04 and #231128-05.

In particular, Resolutions #231128-04 and #231128-05 and the supporting agenda package do not:

- provide a budget and process to authorize and verify the expenditures for legal proceedings, including:
 - if the funds are being reallocated within the existing budget, which items are being reduced and where the funds are being reallocated to in the budget and the impact on the services for the budget items being reduced;
 - if the funds are being drawn from a Restricted Surplus Account, compliance with Policy 447,
 Restricted Surplus Account;
 - an limit on the amount the CAO can authorize to be spent on the legal proceedings before seeking further authorization from Council;
- identify when and if the City will be responsible for the legal costs of third parties to the legal proceedings such as Councillors and the compliance with Policy 801, Council Related Legal Proceedings;
- provide for a purpose which is specific to Ministerial Orders or other action arising from the
 investigation under s. 571 of the MGA into the management, administration and operation of the City,
 or such other specific purpose as the City identifies as appropriate; or
- provide direction to the CAOs regarding reporting to Council on the legal proceedings and legal costs.

As such, I disallow Resolutions #231128-04 and #231128-05.

Resolution #231128-07 to Resolution #231138-14

Resolution #231128-07 to Resolution #231138-14 are all in respect of the Chestermere Regional Community Association (CRCA). The City does not own the CRCA. It does not lease the CRCA. Rocky View County owns the land on which the CRCA is located. The CRCA leases the land from Rocky View County. The CRCA is a non-profit organization. It is run by a Board of Directors.

The City may be exploring purchasing the land from Rocky View County. Even if the City was to purchase the land from Rocky View County, I am unclear how the City would assume operational control and the 2024 Budget from the CRCA as the CRCA leases the land.

There is no agenda report or other documentation supporting these Resolutions. I find them premature and improper and irregular. As such, I disallow Resolutions #231128 -07 to 14. I note that the City can and should work with Rocky View County and the CRCA to improve recreational opportunities within the City. These resolutions are not reflective of healthy cooperation between neighbouring municipalities and community stakeholders.
