**PERMISSION TO CARRY RADIOACTIVE MATERIAL ENDORSEMENT**

In consideration of the premium charged, as set out in the Policy or in the Certificate of Automobile Insurance, permission is hereby given for the automobile to be used to carry the following described type(s) of radioactive material and no other:

Described type(s) of radioactive material:.....

In respect to the portion of the loss or damage arising directly or indirectly out of a nuclear energy hazard as defined in the Automobile Insurance Act, the Insurer's limit of liability under Section A of the Insuring Agreements of the Policy is the Limit of Third Party Liability specified below.

<b>LIMIT OF THIRD PARTY LIABILITY</b>	\$	(EXCLUSIVE OF COSTS AND POST JUDGMENT INTEREST) FOR LOSS OR DAMAGE RESULTING FROM BODILY INJURY TO OR THE DEATH OF ONE OR MORE PERSONS AND FOR LOSS OR DAMAGE TO PROPERTY, REGARDLESS OF THE NUMBER OF CLAIMS ARISING FROM ANY ONE ACCIDENT.

The Limit of Third Party Liability specified in this endorsement shall apply instead of the Limit of Third Party Liability stated in Section A of item 4 of the Policy or in the Certificate of Automobile Insurance, but shall not be in addition to such limit.

The Insurer ..... (waives/does not waive) the exclusion of the insurer's liability for bodily injury or death under Section B – Accident Benefits under section 8 (b) of the General Provisions, Definitions and Exclusions of the Policy, in respect to the carriage of radioactive material.

The Insurer ..... (waives/does not waive) the exclusion of the insurer's liability for physical damage under Section C – Loss of or Damage to Insured Automobile under section 8(b) of the General Provisions, Definitions and Exclusions and/or Exclusion (1)(d) of Section C – Loss of or Damage to Insured Automobile of the Policy, in respect to the carriage of radioactive material.

If more than one automobile is insured under this Policy, this endorsement shall apply only to the automobile(s) described under Item(s) number ..... of the schedule of automobiles attached to and forming part of the Policy or as listed in the Certificate of Automobile Insurance.

Except as otherwise provided in this endorsement, all limits, terms, conditions, provisions, definitions and exclusions of the Policy shall have full force and effect.
